# Ryan Corner Wind Farm

## Project Status

- Wind farm planning permit and associated plans:
  - ✓ The amendment to the permit and its accompanying development plans has been granted. A copy is available on the Ryan Corner wind farm web site.
  - ✓ Mobilisation and site compound establishment (East site entrance – Hamilton Port Fairy Road) commenced in July.
  - ✓ External works road upgrades are progressing on both Youls Road and the intersection with the Princes Highway.
- Connection application & agreements:
  - ✓ Connection application to be submitted to AEMO shortly.
  - ✓ Agreements on-going.

## Activities On Site

- Under progress:
  - ✓ 70% of the components (blades, nacelles, hubs and rotors) arrived and are being stored at Portland. One vessel remaining with the last of the components to arrive in August.
  - ✓ Cultural Heritage Inductions are continuing as contractors come on site
  - ✓ The first spraying for weed eradication on site
  - ✓ Fencing contractor to commence with internal fencing

## Youls Road Upgrade

- ✓ Works are progressing on Youls Road and the Princes Highway external road upgrades.
- ✓ Road sealing works to be completed in August, delays due to weather.
- ✓ West site entrance (Youls Road) gates and fencing being completed in August, delays due to weather.
- ✓ When complete, the external road upgrades will allow wind turbine component delivery vehicles to access the wind farm via Youls Road later this year.

# Transmission Line and Tarrone Terminal Station

- ✓ Works at the Tarrone Terminal Station will start on Monday 1 August
- ✓ Construction works for the transmission line and collector substation are due to commence later in 2022.
- ✓ The Cultural Heritage Management Plan for the transmission line has been endorsed by the Eastern Maar Aboriginal Corporation.
- ✓ A Native Vegetation Removal Permit for the transmission line is progressing.
- ✓ The latest round of geotech surveys for the transmission line are complete. Final Geotech surveys will start soon.

# News from other GPG Australia's projects

Six community projects will gain momentum with the announcement of \$87,102 in grants as part of the newly-launched Berrybank wind farm Grants program.

Funds for this first round of grants are provided by the Berrybank wind farm with the program administered by Corangamite Shire Council alongside its own annual grant programs.

A Berrybank Leverage Grant of \$30,000 will give the Darlington Mechanics Institute Hall Committee of Management help to restump the Darlington Hall. Another Leverage Grant, of \$15,000, will help the Cressy and District History Group move forward with its Water Tower Public Art Project.

A third Leverage Grant, of \$16,187, was approved for the Lismore Men's Shed for construction of ramps, handrails and shelter.

A Berrybank Project Grant of \$8,600 was approved for the Skipton Memorial Pool Committee's proposed installation of a basketball half-court. The Lismore Land Protection Group will receive \$9,860 for improving ecological connectivity through revegetation. The Lismore Recreation Reserve Committee secured \$7,485 for restoration of the Thomas Seymour memorial gates.

GPG Community Engagement Officer, Philip Beattie said: "GPG is proud to provide funds for community projects as part of the Berrybank Stage 1 Community Engagement and Benefit Sharing Plan and we look forward to these grants making a difference in our local communities"
