# Ryan Corner Wind Farm

## Project Update

### Planning Permit and Development Plans

- ✓ Planning permit 20060222-2 has been extended to a completion date of 30 August 2024.
- ✓ The development plans have been updated and endorsed.

### Wind Farm

- ✓ 46 turbines have been fully erected.
- ✓ Civil works are completed and a team remains on site to maintain the access tracks and hard stands.
- ✓ Rehabilitation is continuing as areas are completed.
- ✓ The civil contractors are demobilising from site and some buildings have been removed.
- ✓ Trenching for the underground cabling is completed.
- ✓ Permanent gates and fencing are agreed with landowners and are progressing.

### Transmission Line, Collector Substation and Tarrone Terminal Station

- ✓ Works at the Tarrone Terminal station are complete.
- ✓ The transmission line was energised in December 2023. (
- ✓ Works on the 132kV yard at the Ryan Corner collector sub-station are complete.
- ✓ Works to install the STATCOM (STATic synchronous COMPensator) at the Ryan Corner collector sub-station are complete and ready for energization in the next month.

- ✓ Monday to Friday: ..... 7am to 6pm
- ✓ Saturday: ..... 7am to 4pm (regular)
- ✓ Sunday/Public Holiday: ..... 7am to 1pm (occasional as required)

**Saturday afternoon** (1pm to 4pm) and **Sunday/Public Holiday**, works will be restricted to “managed impact” and “low impact” works as defined by the EPA guidelines.

**Sunday works commenced each week from November 6 2022.**

The purpose of weekend work is to reduce the overall construction duration, and subsequently the duration of impact on the local community. 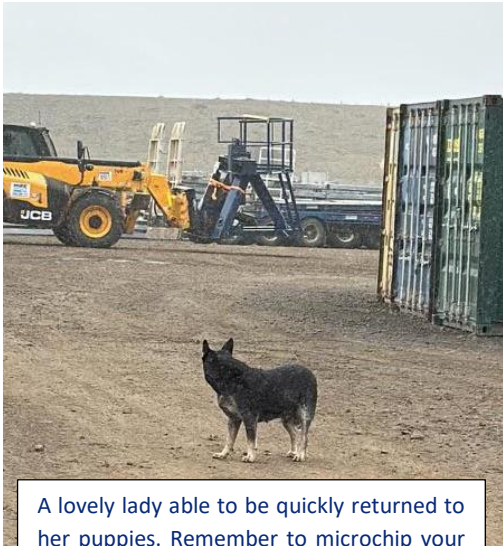
