Project Update

Planning Permit and Development Plans

- ✓ Planning permit 20060222-2 has been extended to a completion date of 30 August 2024.
- ✓ The development plans have been updated and endorsed.

Wind Farm

- ✓ All 52 turbines have been fully erected.
- ✓ A total of nearly 45 km of access tracks are completed and remediation of the areas within the construction footprint are close to being finished.
- ✓ The cranes have relocated to their next project.
- ✓ Nearly 50km of underground cabling is completed.
- ✓ Permanent gates and fencing are agreed with landowners and about 50% are completed.

Transmission Line, Collector Substation and Tarrone Terminal Station

- ✓ Works at the Tarrone Terminal station are complete.
- ✓ The transmission line was energised in December 2023.
- ✓ Works on the 132kV yard at the Ryan Corner collector sub-station are complete.
- ✓ STATCOM (Static Synchronous Compensator) at the Ryan Corner collector sub-station energized 29th June 2024.

- ✓ Saturday: 7am to 4pm (regular)
- ✓ Sunday/Public Holiday:..... 7am to 1pm (occasional as required)

Saturday afternoon (1pm to 4pm) and **Sunday/Public Holiday**, works will be restricted to “managed impact” and “low impact” works as defined by the **EPA guidelines**.

Sunday works commenced each week from November 6 2022.

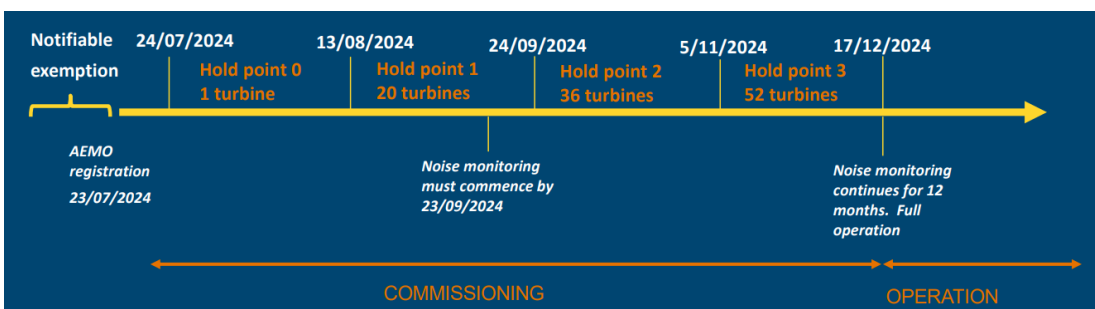

Post Construction Noise Monitoring

Planning Permit 9 March 2022 20060222-2 Condition 32 “within 2 months from the commissioning of the first turbine and continue for 12 months after the commissioning of the last turbine, to the satisfaction of the Minister for Planning”.

The post construction noise monitors will be put in place by mid-August. They will be placed in the same locations that were used for background noise monitoring before construction. Extra receivers will be placed at intermediate locations between the selected residences and the turbines to ensure an accurate noise level is recorded.

The data collected from the noise monitoring will be used for the post construction noise monitoring report for the Minister and the EPA. This data is the basis of the report and will reflect the operation of all the turbines.
