# **Ryan Corner Wind Farm**

### **Project Update**

#### Planning Permit and Development Plans

- ✓ Planning permit 20060222-2 has been extended to a completion date of 30 August 2024.
- ✓ The development plans have been updated and endorsed.

#### Wind Farm

- ✓ All 52 turbines have been fully erected
- ✓ Final remediation works continue
- ✓ The construction site compound is being removed, the office is now located at the sub station
- ✓ Hold Point HPOB commenced July 24, a single turbine operating at a time.
- ✓ On completion of HPOB testing, a report shall be submitted to AEMO (Australian Energy Market Operator) for review and approval. Once AEMO is satisfied testing at the next Hold Point, (Hold Point 1) with 16 turbines operating will be commence.
- ✓ Brolga surveys have commenced and will continue fortnightly until December

# Transmission Line, Collector Substation and Tarrone Terminal Station

- ✓ All works at the Tarrone Terminal station are now complete and in operation
- ✓ All works along the Ryan Corner Transmission line are now complete and in operation
- ✓ All works on the 132kV yard at the Ryan Corner collector sub-station are now complete and in operation
- ✓ All works for STATCOM (Static Synchronous Compensator) at the Ryan Corner collector sub-station are now complete and in operation
